This certificate replaces the former Quality System Certificate dated 2005-04-13

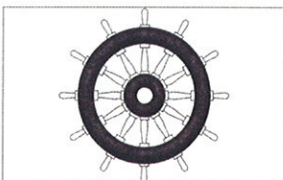
