Description of the PPE:

Jacket and trouser set made in navy blue woven fabric and lining with 5 cm wide discontinuous heat-welded silver retroreflective tape (sleeves) and 7,5 cm-wide discontinuous heat-welded yellow-grey-yellow retroreflective tapes. PPE is available from size XS 42/44 to XXL 66/68.

The materials that form the PPE, are described in the conformity assessment report nº **2024EP1738UE**.

The PPE is available with the following variants:

- PPE can be manufactured in gold colour substituting navy blue contrast fabric with the same composition and weight as the main one, referenced as: Jacket 12-6985GHV, trouser 12-6785G.

It shall be the manufacturer's responsibility to provide specific information of this certificate and the tested levels of protection.
